We are pleased to continue offering a winter tennis membership at Sea Colony for the 2019-2020 season. We have extended the winter membership from September 3, 2019 to May 21, 2020 which provides an enhanced opportunity to play more tennis. Sea Colony continues to invest in our world class tennis facility. Over the past few years we significantly upgraded the parking lot, improved the drainage around the entire facility, and completely resurfaced all the outdoor hard courts. Plans for the future include LED lighting for the indoor courts, resurfacing the indoor hard courts, adding permanent pickleball courts, and replace the fencing around the clay courts. ALL guests who play are subject to a \$20 fee, and are limited to **4 visits** in a season, after which they must become a member or will not be permitted to play. Guests are defined as non-Sea Colony owners who are local domiciled residents of Sussex County, Worcester County and Wicomico County.

Winter Members are entitled to a 10% discount on retail items in the Pro-Shop. Winter Members (and Homeowners) are also invited to take advantage of our Private Lesson special; buy 5 privates, and get a 6th free (valid through April 30, 2020).
