

Dear Winter Member,

We are pleased to continue offering a Winter Tennis Membership at Sea Colony with no price increase for the 2021-2022 season. We have also extended the Winter Membership from September 7, 2021 to May 26, 2022 which provides an enhanced opportunity to play more tennis.

Individual Membership: \$250

Family: \$400

In addition to the Membership fee, there is a \$15 per play fee (per person) for indoors and a \$10 per play fee (per person) for outdoors. For the avid player(s), there is an “all you can play” fee of \$1150 per member in addition to the membership fee; no additional “per play” fees would be due.

Indoor Block Time will remain the same and be available October 4, 2021—April 29, 2022. As in the past, two Winter Members are needed to reserve the one and a half hour blocks of time. It is helpful to designate one person as the Captain for a tennis group to organize playing times; however, Winter Members and Homeowners must still apply for their own Block Times. All members **MUST** check in and pay (if applicable) at the front desk prior to going out to the courts (even if it is multiple times in the same day). **Please submit block time requests by Monday, September 27, 2021.**

ALL guests who play are subject to a \$20 fee, and are limited to **4 visits** in a season, after which they must become a member or will not be permitted to play. Guests are defined as non-Sea Colony owners who are local domiciled residents of Sussex County, Worcester County and Wicomico County.

If you need to cancel a reserved court time or cannot use a scheduled block time, you must cancel the court within 24 hours or contact the front desk ASAP in extenuating circumstances. The Tennis Committee has instituted a three-tiered penalty process. All individuals (Homeowners and Winter Members), who do not cancel their court time (reservation and block time) 24 hours in advance, will initiate a three-tiered penalty process.

- The first offense will result in the individual receiving a verbal and written warning (via email).
- The second offense will result in a \$50 fine. Payable at the tennis desk before additional reservations or play.
- The third offense will result in the revocation of tennis reservation and playing privileges for one month.

Winter Members are entitled to a 10% discount on retail items in the Pro-Shop. Winter Members (and Homeowners) are also invited to take advantage of our private lesson special; buy 5 privates, and get a 6th free.
