Executive Board Reports

Treasurer Report – John Liles (see attached detailed report)

- Current total assets are \$200,030.50.
- Income of \$803 includes \$666 from league tennis.
- Current total liabilities are \$15,766.27.
- Primary expenses of \$2354 include Captains' gifts, Jr. tennis incentives, and November meeting expenses.
- 2021 proposed budget is the same as the 2020 budget, with \$98,000 projected income and \$88,000 projected expenses.

President Report – Rhonda Rubben

- Copies of 2021 budget were distributed for review. Budget was approved. Motion by Grady Wilson, second by Albert Harrison.
- 2021 calendar is out. Pros should review and/or add tournament dates.
- Rhonda has submitted a bid for the 55 and over State tournament (previously awarded to Lake Charles). Host sites will be POTC and Querbes, and tentative dates are April 16-18th, pending hotel availability.
- \$895 in Captain gifts included \$25 for first time captains and \$10/team for captains of 4 or more teams. Executive Board has approved. Motion by Willie Paz, second by Chris Dudley. Will do this again in 2021.
