Executive Board Reports:

President Report Brian Bernard

- USTA Local League Facility Court Fee Agreement
 - o 104C(2)Local League Facility Court Fees -

As agreed, by facilities listed under 1.04E Facilities permitted for local league play and adopted by the NWLACTA Board:

- IF the home team is a Public Court Team and the visiting team is a Private Club Team the Public Court Home Team pays
- the court fee for 1 (one) Private Club Team player.
- IF the home team is a Public Court Team and the visiting team is a Public Court Team each team pays their own court fees
- If the home team is a Private Club Team NO court fees are paid.
- Will add that "Should any player refuse to pay the appropriate fees stated above the player will not be allowed to play the scheduled USTA match.
- Community Partners
 Raised \$6500 to date, \$500 in AR from Canes.

Treasurer's Report Steve Craig

- Assets: \$ 245541, including \$ 158194 cash (\$22108 restricted), \$ 76597 Merrill Lynch.
- Liabilities: \$ 4250, including \$ 2708 credit card and \$1542QTC(restricted).
- Total income for March 2024: \$ 44351, includes \$2400 for spring league, \$19000 CTA Tourn, \$6825 70 Tourn, and \$5395 Tennis Apprentice
- Total expenses for March 2024: \$ 25468, including \$ 1197 QTC (to be reimb SPAR), \$10130 BOLD exp, \$5887 70 tourn, and \$1745 TA expense to date.
- Balance Sheet and P & L by MTH YTD available for review.

USTA League fee concern: Roland Deville submitted a petition for discussion regarding league court fees (please see attached handout), was given the floor and he explained a group wanted the fee removed stating it was unfair. Discussion was open, no other opposition was made. It was brought up that private clubs currently charge a \$20 guest fee that is waived with the current USTA court fee structure in place. However, if the current USTA Local Fee structure were removed then the \$20 guest fee would be implemented. Discussion was additionally made that this would cost the public court players more in USTA league fees. This agreement has been "In Standing" since the late 90's made by the facility directors and adopted by the Local League and CTA Board. It was signed by the Directors again in 2022.

All the Facility Directors/Board Members in attendance were in favor of keeping the Standing Agreement. A motion was made by Grady Wilson, second by Philip Campbell, the board voted <u>unanimously</u> to keep the agreement in place. President Brian Bernard verbalized that no change would be made to the current structuring of league fees and suggested the current agreement be adopted into the Local Rules & Regulations for further clarification of this policy. Any player refusing to pay the appropriate court fees would not be allowed to play the USTA match for that day/night. Roland asked what if a player refuses and is a member of Bossier Tennis Center. Todd Killen stated he would refund membership fees for persons who are upset about this fee. This agreement has been in effect since the 90's.

Unfortunately, disqualifications happen every year. Impacts the player and the player's team.

Follow and answer questions accurately and disclose all information from your athletic history.

Players can be suspended if found not to have reported accurately

Pay close attention to questions regarding high school and college experience.

There is no limit to how long-ago college sports was played...report it

A player can appeal a ranking during the self-ranking process

Incorrect reporting will forfeit appeal rights.
