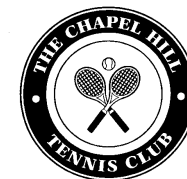
An indoor court contract is a non-refundable advanced purchase of guaranteed court time for a specific time each week throughout the indoor tennis season.

CHTC 2020-2021 Indoor Court Contract Application Instructions

- 2020-2021 contract season details are described on the back of this form.
- Priority will be given to groups with the highest percentage of members (note member status on the bottom of this form).
- **Application schedule:**
 1. Previous year contract holders (*members only*) have first choice to select their same time slot for the upcoming season until **June 17th**.
 2. As of **June 18th**, new contract sales are open to all **members**.
 3. As of **July 1st**, **renewing contract sales are open to non-members if any are left**.
 4. As of **August 1st**, new contract sales are open to everyone if any are left.
- A \$100.00 non-refundable deposit is required with this application. The deposit may be made by cash or check payable to Chapel Hill Tennis Club. **The deposit cannot be billed. The balance of the fee is due September 15, 2020.**
- List all the players in your group under "Names of Group Members" below.
- For non-members participating in a member's group, a **\$75 additional surcharge** must be added per non-member. There is a limit of **2 non-members per member contract**.
