## Pro Shop Minimum Program

Individual members will be charged \$20/quarter and parent/child, couple, and family members will be charged \$25/quarter (quarterly account charges billed Sep. 1, Dec. 1, Mar. 1, and June 1). Once charged to member accounts, they are immediately available to spend on qualifying purchases at the MVRC Pro Shop and will remain valid on account for one year from the billing date. Qualifying purchases include racquets, footwear, apparel, bags, strings, grips, tennis accessories, and tennis balls. Pro Shop Minimums are non-transferable.

## Cancellation Policy

MVRC has a 24-hour cancellation policy for court time, lessons, drills, programs, and special events. Any cancellations made with less than 24 hours notice will be charged at full adult rates. If a court time is cancelled with less than 24 hours notice, the club will attempt to sell the court. Any portion of the court time that sells will not be billed to your account.

The same cancellation policy applies to members on Unlimited Programs. If an unlimited program player cancels with less than 24 hours notice or no-shows a court time, the applicable court time rate will be charged to his/her account.
