## **In making this application, I understand and agree that:**

All memberships are subject to the approval of the management of Paramount Tennis Club.

No member may sell or transfer his/her membership.

Membership fees are non-refundable.

It is understood that the prospective member assumes no liabilities whatsoever in connection with this membership other than that of payment of membership fee, court charges, usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guests in the use of the Club. It is also understood members and guests assume full responsibility for any injuries or losses that may occur while participating or witnessing in any club programs or events.

Membership fees, court usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guest in the use of the Club are nonrefundable and subject to change (such charges and fees will not be applied retroactively).

Members will receive a monthly statement on the 1st of every month and ACH debit on the 11th of the month. The Club may assess finance charges on delinquent accounts. Renewal of annual membership will automatically be billed on member's anniversary date unless member notifies club.

**Season/Permanent Courts...**We offer permanent court reservations which assures the same court each week. This permanent court time, however, commits the member for the entire season. Permanent courts are billed in 2 installments - In September and January.

**One Time Only Courts...**One time only court reservations may be made up to six days in advance. There will be no charge for reserved court time if cancellations are received at least 24 hours in advance. "No shows" or courts cancelled less than 24 hours in advance will be charged the full rate. We will make every effort to sell court time available due to cancellation.

Guests...Guests must sign in at the Front Desk prior to going onto the court. Each person may be a guest at the Club up to 5 times a year. The guest fee is \$6 per person per visit.

Please, go on the courts only at the start of your scheduled court time, and be prompt leaving the courts at the conclusion of your scheduled court time.

Children must be under direct supervision at all times. Children under the age of 10 must and can not be left unattended in the lounges. Experience indicates that unsupervised or unattended children of any age can be a disturbance and distraction to our members and guests. Children can not be left without direct supervision in the lounges while the parent or guardian is playing tennis. Children may not go on the tennis courts for any reason unless they are actively playing tennis under adult supervision. Please review our Club brochure and information posted throughout the Club to supplement the information above.
